MAV needs to be an effective advocate for regional and rural Victoria. As the Mayor of Wodonga Council and as a Board Director of both private sector and government entities, I have a strong track record in effective advocacy and governance. Most significant of these was as Director of Hume Bank for 11 years, 6 years as Chair. Local Government is facing tremendous challenges, none more so than financial. With relentless cost shifting from State Government the problem is further exacerbated by cost inflation and rate caps. Regional and rural councils are feeling the pressure more so than our metro counterparts. We typically have larger geographies and smaller populations to help pay for these additional costs. The addition of the new Emergency Service Volunteer Fund levy will disproportionately impact regional and rural Local Governments with our rural ratepayers facing huge increases. The collection of this levy being imposed on Local Government will have both reputational and cost implications. In addition issues around loss of Local Government planning controls to influence developments objectionable to some of our communities needs to be addressed. I seek your support to advocate on these key issues.
